**PURPOSE:** The purpose of this resolution is to confirm the selection of a chairperson and vice-chairperson to the Health, Education and Human Services Committee.


This written summary does not address recommended amendments as may be provided by the standing committees. The Office of Legislative Counsel requests each Council Delegate to review each proposed resolution in detail.
