
**PURPOSE:** The purpose of the resolution is for the Resources and Development Committee, on behalf of the Navajo Nation, to approve the Fiscal Year 2020 Navajo Housing Plan for NAHASDA Indian Housing Block Grant Funding. The Resources and Development Committee, through this resolution, also authorizes the Navajo Housing Authority to submit the Fiscal Year 2020 Navajo Housing Plan on behalf of the Navajo Nation.

This written summary does not address recommended amendments as may be provided by the standing committees. The Office of Legislative Counsel requests each Council Delegate to review each proposed resolution in detail.

20 approval for the Native American Housing Assistance and Self-Determination  
21 Act of 1996 (NAHASDA) Indian Housing Plan. 2 N.N.C. §501 (B)(2)(b).

23 **Section Two. Findings**

24 The Board of Commissioners of the Navajo Housing Authority, by Resolution  
25 NHA-4910-2019, attached hereto as **Exhibit B**, requests the support and  
26 endorsement of the Navajo Nation Council Resources and Development  
27 Committee to approve the Fiscal Year 2020 Navajo Nation Housing Plan for  
28 the NAHASDA Indian Housing Block Grant funding and to authorize the  
29 submission of the Navajo Nation Indian Housing Plan by the Navajo Housing  
30 Authority on behalf of the Navajo Nation.
