17 **SECTION ONE. AUTHORITY**

- 18 A. The Health, Education and Human Services Committee is a standing committee of  
19 the Navajo Nation Council. 2 N.N.C. § 400(A).  
20 B. The Health, Education and Human Services Committee is the oversight committee  
21 for the Navajo Nation Division of Social Services. 2 N.N.C. § 401(B)(1).  
22 C. Each oversight committee shall review and make recommendations to the Budget  
23 and Finance Committee concerning the budget in accordance with the annual  
24 budget instructions. 12 N.N.C. § 840 (A).

26 **SECTION TWO. FINDINGS**

- 27 A. The Health, Education and Human Services Committee held a budget hearing and  
28 took budget testimony regarding the Navajo Nation Division of Social Services  
29 Fiscal Year 2019 Budget. 12 N.N.C. § 840 (A).  
30 B. The Health, Education and Human Services Committee recommends to the Budget

1 and Finance Committee a fiscal year budget for the Navajo Nation Division of Social  
2 Services. 12 N.N.C. § 840 (A).

- 12 B. The Health, Education and Human Services Committee requests that the Budget and  
13 Finance Committee and the Navajo Nation Council adopt the changes to the Budget,  
14 as set forth in the General Fund Comparative Summary, **Exhibit B**, Recommended  
15 Changes to the General Fund Budget, **Exhibit C**, Recommended Conditions of  
16 Appropriation and Legislative Concerns, **Exhibit D**, and Recommended Unmet Needs,  
17 **Exhibit E**.
- 18 C. The Health, Education and Human Services Committee authorizes the Committee  
19 Chairperson or Vice-Chairperson to meet and negotiate with the Budget and Finance  
20 Committee on these recommendations.
