

22 and Finance Committee concerning the budget in accordance with the annual  
23 budget instructions. 12 N.N.C. § 840 (A).  
24 C. The Budget and Finance Committee has oversight of the Office of the Controller.  
25 12 N.N.C. §301(B)(13).

27 **SECTION TWO. FINDINGS**

- 28 A. The Budget and Finance Committee held a hearing and took budget testimony  
29 regarding the Office of the Controller, Fiscal Year 2020 Budget. 12 N.N.C. § 840
