BE IT ENACTED:

**SECTION ONE. AUTHORITY**

- A. The Resources and Development Committee is a standing committee of the Navajo Nation Council. 2 N.N.C. § 500(A).
- B. The Resources and Development Committee is the oversight committee for the Navajo Gaming Regulatory Office. 2 N.N.C. § 501(C)(1).
- C. Each oversight committee shall review and make recommendations to the Budget and Finance Committee concerning the budget in accordance with the annual budget instructions. 12 N.N.C. § 840 (A).

**SECTION TWO. FINDINGS**

- A. The Resources and Development Committee held a budget hearing and took budget testimony regarding the Navajo Gaming Regulatory Office’s Fiscal Year 2020 Budget. 12 N.N.C. § 840 (A).

1 B. The Resources and Development Committee recommends to the Budget and  
2 Finance Committee a fiscal year budget for the Navajo Gaming Regulatory
