

BE IT ENACTED:

**SECTION ONE. AUTHORITY**

- A. The Resources and Development Committee ("RDC") is established as a standing committee of the Navajo Nation Council with oversight committee for the Division of Natural Resources. 2 N.N.C. § 500(A); 2 N.N.C. § 501(C)(1).
- B. The Resources and Development Committee is empowered to grant final approval for Plans of Operation for the Division of Natural Resources. 2 N.N.C. § 501(B)(2)(g).

**SECTION TWO. FINDINGS**

- A. The Plan of Operation for the Navajo Nation Division of Natural Resources ("DNR") Parks and Recreation Department was last updated through RDCO-79-16 at Exhibit I. RDCO-79-16 (Exhibits A-H and J-M omitted) is attached as **Exhibit 2**.

1 B. The Navajo Nation Division of Natural Resources Parks and Recreation  
2 Department has submitted amendments to their plan of operation and is attached as  
3 **Exhibit 1.**

5 **SECTION THREE. AMENDING RDCO-79-16 BY APPROVING**
