WINDOW ROCK, Ariz. — Kee Allen Begay Jr., chairman of the Judiciary Committee of the 21st Navajo Nation Council, sends his appreciation on behalf of the committee to Chief Justice Herb Yazzie, the Judicial Branch of the Navajo Nation, the district court staff, administrators and judges for planning and coordinating the 50th Annual Justice Day festivities on the Navajo Nation.

The Judiciary Committee, the oversight standing committee for the Judicial Branch, continues its work to make sure the Navajo public receives quality and effective court services throughout the Navajo Nation.

"The Navajo Nation has come a long way in upholding our Navajo culture and tradition distinctively and keeping a strong stance in protecting our sovereignty and jurisdictional affairs within the Navajo Nation," Begay said. "Each and every year, the committee works tirelessly to request for increased funding for each of the district courts. We also make sure all policy and procedures for the courts are up to date as well."

Begay explained the Judiciary Committee keeps abreast of laws that effect the sovereign status of the Navajo Nation and makes sure that its culture and tradition is acknowledged, all while experiencing an increase in population and changes in our social environment.

"Our Navajo district court jurisdiction has a long way in obtaining full unquestionable jurisdiction and it must be acknowledged by our U.S. Congress to obtain that authority," Begay said. "In obtaining this status, it will need the support and advocacy of each and every Navajo in order to achieve this status."
