PURPOSE: The purpose of the resolution is to identify the funding option and project management and procurement method to be used for each of the five United States Department of Interior, Indian Affairs, Office of Facilities, Property and Safety Management, Division of Facilities Management and Construction projects.

18 **SECTION ONE. AUTHORITY**

19 The Naabik'iyáti' Committee is a standing committee of the Navajo Nation Council
20 and among other statutory powers, the committee has the delegated responsibility to
21 "review and continually monitor the programs and activities of federal and state
22 departments and to assist development of such programs designed to serve the Navajo
23 People and the Navajo Nation through intergovernmental relationships between the
24 Navajo Nation and such departments." See 2 N.N.C. §§ 700 (A) and 701 (A)(7).

26 **SECTION TWO. FINDINGS**

27 A. The United States Department of Interior, Indian Affairs, Office of Facilities,
28 Property and Safety Management, Division of Facilities Management and
29 Construction ("Division of Facilities Management & Construction") has selected five
30 major Facilities, Improvement and Repair projects to fund on the Navajo Nation.

- 1 B. The Division of Facilities Management & Construction requires a "Tribal Resolution
2 identifying the funding option and project management and procurement method" to
3 be used for each of the funded projects.
- 4 C. The Facility Improvements and Repair projects are listed in five letters from the
5 United States Department of Interior, Indian Affairs. These letters are attached as
6 **Exhibit A**. The Facility Improvements and Repair projects include a Demolition and
7 Space Reduction projects at Greasewood Springs Community School; a Facility
8 Improvement and Repair project at Greyhills Academy High School; a Demolition
9 Project for various unspecified locations on the Navajo Nation; a Facilities
10 Improvement and Repair Project at Many Farms Consolidated School; and a Facility
11 Improvement and Repair Project at Shonto Preparatory School.
- 12 D. The Navajo Nation and Bureau of Indian Affairs document showing the proposed
13 projects and the budgeted amounts for the five projects is attached as **Exhibit B**. The
14 estimated total for all five projects is listed at \$45.8 million.
- 15 E. The Navajo Nation President's DECISION OF FUNDING CONTRACT FOR
16 PROJECT MANAGEMENT for each of the five projects are attached as **Exhibit A**.

18 **SECTION THREE. IDENTIFYING THE FUNDING OPTION AND PROJECT**
19 **MANAGEMENT AND PROCUREMENT METHOD TO BE USED FOR EACH**
20 **OF THE FIVE UNITED STATES DEPARTMENT OF INTERIOR, DIVISION OF**
21 **FACILITIES MANAGEMENT AND CONSTRUCTION PROJECTS**

22 The Navajo Nation through the 24th Navajo Nation Council Naabik'íyáti' Committee
23 hereby identifies the funding option and project management and procurement
24 method to be used for each of the five United States Department of Interior, Indian
25 Affairs, Office of Facilities, Property and Safety Management, Division of Facilities
26 Management and Construction projects as shown in **Exhibit A**.
