18 **Section One. Authority**

- 19 1. The Resources and Development Committee exercises authority over chapters of  
20 the Navajo Nation. 2 N.N.C. § 501(C)(1).  
21 2. The Budget and Finance Committee of the Navajo Nation Council exercises  
22 authority over budgeting, appropriation, investment and management of all funds.  
23 2 N.N.C. § 301 (B)(2).  
24 3. Council Resolution CAP-35-18 provides, “[a] chapter project, powerline, or  
25 waterline project may be changed, including the year funded, or added to Exhibits  
26 A through E with the concurrence of the Delegate representing the chapter’s  
27 Council District and the approvals of the Resources and Development Committee  
28 and Budget and Finance Committee, as long as such project has been certified as  
29 construction-ready by CPMD or NTUA and the total Síhasin Funding for the  
30 District does not exceed \$4,166,666.67.” **Exhibit 1**, Section Four, Paragraph C.

1       **Section Two. Findings**

- 2       A. The Navajo Nation Council adopted Council Resolution CAP-35-18, "Adopting the  
3       Sihasin Fund Powerline and Chapter Projects Expenditure Plan Pursuant to CD-68-14,  
4       as Amended by CJA-03-18, and 12 N.N.C. §§ 2501-2508, as Amended; Waiving 12  
5       N.N.C. §§ 810 (F), 820 (I) and (M) and 860 (C) Relating to the Capital Budget and  
6       Capital Improvement Process" on April 17, 2018, which is attached as **Exhibit 1**.
- 7       B. St. Michaels Chapter submitted a CAP-35-18 Project Change Form, which is attached as  
8       **Exhibit 2**.
- 9       C. The CAP-35-18 Project Change Form indicates the following changes to be made to the  
10      project:
- 11          1. The Project Description is to change from New Chapter House to Chapter  
12          House Renovation and Addition,
  - 13          2. The Project Type is to change from Construction to Plan, Design, Construction,  
14          and Equipment,
  - 15          3. The Project Duration is to change from 10-14 months to 36 months, and  
16          4. The Project Funding is to change from Year 1 to Year 2 funding.
- 17      D. For reference, the St. Michaels Chapter House Project is included in **Exhibit 1**, Exhibit  
18      D, Project 100.
- 19      E. St. Michaels Chapter Resolution, No. 10-21-18-02, dated October 2, 2018, is attached as  
20      **Exhibit 3**.

22       **Section Three. Approval**

23       The Navajo Nation hereby approves the changes to the St. Michaels Chapter House Project as  
24       indicated in **Exhibit 2** and described in Section 2, Paragraph C(1)-(4).
