
PURPOSE: The purpose of this resolution is to recommend the Fiscal Year 2021 budget for the legislative branch to the Budget and Finance Committee.

BE IT ENACTED:

SECTION ONE. AUTHORITY

- A. The Naabik'iyáti' Committee is a standing committee of the Navajo Nation Council. 2 N.N.C. § 700(A).
- B. The Naabik'iyáti' Committee is the oversight committee for the Office of Legislative Services and other offices, programs, commissions, boards or task forces under the Legislative Branch and the Naabik'iyáti' Committee has the power to prepare and recommend approval of a Committee budget each fiscal year. 2 N.N.C. §§ 701(A)(5) , 701 A(13).
- C. Each oversight committee shall review and make recommendations to the Budget and Finance Committee concerning the budget in accordance with the annual budget instructions. 12 N.N.C. § 840 (A).

SECTION TWO. FINDINGS

1 A. The Naabik'iyáti' Committee held a budget hearing and took budget testimony
2 regarding the Navajo Nation Legislative Branch Fiscal Year 2020 Budget. 12
3 N.N.C. § 840 (A).

4 B. The Naabik'iyáti' Committee recommends to the Budget and Finance Committee
5 a fiscal year budget for the Navajo Nation Legislative Branch. 12 N.N.C. § 840
6 (A).

8 **SECTION THREE. APPROVING AND RECOMMENDING TO THE BUDGET**
9 **AND FINANCE COMMITTEE THE PROPOSED FISCAL YEAR 2021 BUDGET**
10 **FOR THE NAVAJO NATION LEGISLATIVE BRANCH**

11 A. The Naabik'iyáti' Committee hereby approves the proposed Navajo Nation Fiscal Year
12 (FY) 2021 Budget for the Navajo Nation Legislative Branch, recommended by the
13 Speaker of the Navajo Nation, as provided on the Fund Type Budget Summary,
14 attached as **Exhibit A**.

15 B. The Naabik'iyáti' Committee recommends that the Budget and Finance Committee and
16 the Navajo Nation Council adopt the changes to the Budget, as set forth in the General
17 Fund Comparative Summary **Exhibit B**, Recommended Changes to the General Fund
18 Budget, **Exhibit C**, Recommended Conditions of Appropriation and Legislative
19 Concerns, **Exhibit D**, and Recommended Unmet Needs, **Exhibit E**.

20 C. The Naabik'iyáti' Committee authorizes the Committee Chairperson to meet and
21 negotiate with the Budget and Finance Committee on these recommendations.
