**PURPOSE:** The purpose of this resolution is approve a project change for Many Farms Chapter from funding year 2 to funding year 3.



17 **Section One. Authority**

- 18 1. The Resources and Development Committee exercises authority over chapters of  
19 the Navajo Nation. 2 N.N.C. § 501(C)(1).  
20 2. The Budget and Finance Committee of the Navajo Nation Council exercises  
21 authority over budgeting, appropriation, investment and management of all funds.  
22 2 N.N.C. § 301 (B)(2).  
23 3. Council Resolution CAP-35-18 provides, “[a] chapter project, powerline, or  
24 waterline project may be changed, including the year funded, or added to Exhibits  
25 A through E with the concurrence of the Delegate representing the chapter’s  
26 Council District and the approvals of the Resources and Development Committee  
27 and Budget and Finance Committee, as long as such project has been certified as  
28 construction-ready by CPMD or NTUA and the total Sihasin Funding for the  
29 District does not exceed \$4,166,666.67.” Exhibit 1, Section Four, Paragraph C.

1           **Section Two. Findings**

- 2           A. The Navajo Nation Council adopted Council Resolution CAP-35-18, "Adopting the  
3           Sihasin Fund Powerline and Chapter Projects Expenditure Plan Pursuant to CD-68-14,  
4           as Amended by CJA-03-18, and 12 N.N.C. §§ 2501-2508, as Amended; Waiving 12  
5           N.N.C. §§ 810 (F), 820 (I) and (M) and 860 (C) Relating to the Capital Budget and  
6           Capital Improvement Process" on April 17, 2018, which is attached as **Exhibit 1**.
- 7           B. Many Farms Chapter submitted a CAP-35-18 Project Change Form, which is attached as  
8           **Exhibit 2**. For reference, the Many Farms project is included in **Exhibit 1**, Exhibit D,  
9           Project 11.
- 10          C. Many Farms Chapter submitted a chapter resolution, MF-10-11-2019, which is included  
11          in **Exhibit 3**, along with a Market Study Proposal, in support of this request.
- 12          D. Many Farms Chapter requests to change the approved funding year in CAP-35-18 to  
13          delete \$265,000 from year two funding in project D-11 and to add \$265,000 in year  
14          three funding.

16           **Section Three. Approval**

17           The Navajo Nation hereby approves the project change requested by Many Farms  
18           Chapter in accordance with **Exhibit 2**.
