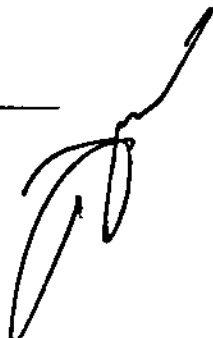

BE IT ENACTED:

**SECTION ONE. AUTHORITY**

- A. The Health, Education and Human Services Committee is a standing committee of the Navajo Nation Council. 2 N.N.C. § 400(A).
- B. The Health, Education and Human Services Committee is the oversight committee for the Navajo Nation Department of Diné Education. 2 N.N.C. § 401(C)(1).
- C. Each oversight committee shall review and make recommendations to the Budget and Finance Committee concerning the budget in accordance with the annual budget instructions. 12 N.N.C. § 840 (A).

**SECTION TWO. FINDINGS**

- A. The Health, Education and Human Services Committee held a budget hearing and took budget testimony regarding the Navajo Nation Department of Diné Education' Fiscal Year 2021 Budget. 12 N.N.C. § 840 (A).

11 of Diné Education, recommended by the Office of Navajo Nation President and Vice  
12 President, as provided on the Fund Type Budget Summary, attached as **Exhibit A**.

13 B. The Health, Education and Human Services Committee requests that the Budget and  
14 Finance Committee and the Navajo Nation Council adopt the changes to the Budget,  
15 as set forth in the General Fund Comparative Summary, **Exhibit B**, Recommended  
16 Changes to the General Fund Budget, **Exhibit C**, Recommended Conditions of  
17 Appropriation and Legislative Concerns, **Exhibit D**, and Recommended Unmet  
18 Needs, **Exhibit E**.

19 C. The Health, Education and Human Services Committee authorizes the Committee  
20 Chairperson or Vice-Chairperson to meet and negotiate with the Budget and Finance
