21 for the Navajo Nation Department of Health. 2 N.N.C. § 401(C)(1).
22 C. Each oversight committee shall review and make recommendations to the Budget
23 and Finance Committee concerning the budget in accordance with the annual
24 budget instructions. 12 N.N.C. § 840 (A).

26 SECTION TWO. FINDINGS

- 27 A. The Health, Education and Human Services Committee held a budget hearing and
28 took budget testimony regarding the Navajo Nation Department of Health's Fiscal
29 Year 2021 Budget. 12 N.N.C. § 840 (A).

17 Appropriation and Legislative Concerns, **Exhibit D**, and Recommended Unmet Needs,
18 **Exhibit E**.
19 C. The Health, Education and Human Services Committee authorizes the Committee
20 Chairperson or Vice-Chairperson to meet and negotiate with the Budget and Finance
21 Committee on these recommendations.
