23 and Finance Committee concerning the budget in accordance with the annual  
24 budget instructions. 12 N.N.C. § 840 (A).

- 27 A. The Resources and Development Committee held a budget hearing and took  
28 budget testimony regarding the Navajo Gaming Regulatory Office’s Fiscal Year
