19 SECTION ONE. AUTHORITY

22 B. Each oversight committee shall review and make recommendations to the Budget
23 and Finance Committee concerning the budget in accordance with the annual
24 budget instructions. 12 N.N.C. § 840 (A).
25 C. The Budget and Finance Committee has oversight of the Office of the Auditor
26 General. 12 N.N.C. §301(B)(13).

28 SECTION TWO. FINDINGS

1 A. The Budget and Finance Committee held a hearing and took budget testimony
2 regarding the Office of the Auditor General, Fiscal Year 2021 Budget. 12 N.N.C.
3 § 840 (A).

4 B. The Budget and Finance Committee recommends a fiscal year budget for the Office
5 of the Auditor General. 12 N.N.C. § 840 (A).

16 incorporated into the Navajo Nation Comprehensive Budget.
