

21 Division of Public Safety 2 N.N.C. § 601(C)(1).
22 C. Each oversight committee shall review and make recommendations to the Budget
23 and Finance Committee concerning the budget in accordance with the annual
24 budget instructions. 12 N.N.C. § 840 (A).

16 General Fund Budget, **Exhibit C**, Recommended Conditions of Appropriation and
17 Legislative Concerns, **Exhibit D**, and Recommended Unmet Needs, **Exhibit E**.
- 18 C. The Law and Order Committee authorizes the Committee Chairperson or Vice-
19 Chairperson to meet and negotiate with the Budget and Finance Committee on these
20 recommendations.
