

23 B. Each oversight committee shall review and make recommendations to the Budget  
24 and Finance Committee concerning the budget in accordance with the annual  
25 budget instructions. 12 N.N.C. § 840 (A).  
26 C. The Budget and Finance Committee has oversight of Retirement Services and  
27 Retirement Funds. 12 N.N.C. §301(B)(13).

29 SECTION TWO. FINDINGS

- 1 A. The Budget and Finance Committee held a hearing and took budget testimony  
2 regarding the Human Resources Division – Retirement Services, Retirement  
3 Funds, Retirement Plan Administration Committee, Fiscal Year 2021 Budget. 12

- 5 B. The Budget and Finance Committee recommends a fiscal year budget for the  
6 Human Resources Division – Retirement Services, Retirement Funds, Retirement
