17 SECTION ONE. AUTHORITY

- 18 A. The Naabik'iyáti' Committee is a standing committee of the Navajo Nation  
19 Council. 2 N.N.C. § 700(A).  
20 B. The Naabik'iyáti' Committee is the oversight committee for the Navajo Nation  
21 Executive Offices. 12 N.N.C. § 840(A).  
22 C. Each oversight committee shall review and make recommendations to the Budget  
23 and Finance Committee concerning the budget in accordance with the annual  
24 budget instructions. 12 N.N.C. § 840 (A).

26 SECTION TWO. FINDINGS

- 27 A. The Naabik'iyáti' Committee held a budget hearing and took budget testimony  
28 regarding the Navajo Nation Executive Office's Fiscal Year 2021 Budget. 12  
29 N.N.C. § 840 (A).

1 B. The Naabik'iyáti' Committee recommends to the Budget and Finance Committee  
2 a fiscal year budget for the Navajo Nation Executive Offices. 12 N.N.C. § 840 (A).

4 **SECTION THREE. ACCEPTING AND RECOMMENDING TO THE BUDGET**  
5 **AND FINANCE COMMITTEE THE PROPOSED FISCAL YEAR 2021 BUDGET**  
6 **FOR THE NAVAJO NATION EXECUTIVE OFFICES**

8 A. The Naabik'iyáti' Committee hereby accepts the proposed Navajo Nation Fiscal Year  
9 (FY) 2021 Budget for the Navajo Nation Executive Offices, recommended by the  
10 President of the Navajo Nation, as provided on the Fund Type Budget Summary,  
11 attached as **Exhibit A**.

12 B. The Naabik'iyáti' Committee requests that the Budget and Finance Committee and the  
13 Navajo Nation Council adopt the changes to the Budget, as set forth in the General  
14 Fund Comparative Summary **Exhibit B**, Recommended Changes to the General Fund  
15 Budget, **Exhibit C**, Recommended Conditions of Appropriation and Legislative  
16 Concerns, **Exhibit D**, and Recommended Unmet Needs, **Exhibit E**.

17 C. The Naabik'iyáti' Committee authorizes the Committee Chairman to meet and  
18 negotiate with the Budget and Finance Committee on these recommendations.
