BE IT ENACTED:

SECTION ONE. AUTHORITY

- A. The Health, Education and Human Services Committee is a standing committee of the Navajo Nation Council. 2 N.N.C. § 400(A).
- B. The Health, Education and Human Services Committee is the oversight committee for the Navajo Nation Veterans Administration. 2 N.N.C. § 401(B)(1).
- C. Each oversight committee shall review and make recommendations to the Budget and Finance Committee concerning the budget in accordance with the annual budget instructions. 12 N.N.C. § 840 (A).

SECTION TWO. FINDINGS

- A. The Health, Education and Human Services Committee held a budget hearing and took budget testimony regarding the Navajo Nation Veterans Administration Fiscal Year 2020 Budget. 12 N.N.C. § 840 (A).
- B. The Health, Education and Human Services Committee recommends to the Budget

15 Changes to the General Fund Budget, **Exhibit C**, Recommended Conditions of
16 Appropriation and Legislative Concerns, **Exhibit D**, and Recommended Unmet Needs,
17 **Exhibit E**.
- 18 C. The Health, Education and Human Services Committee authorizes the Committee
19 Chairperson or Vice-Chairperson to meet and negotiate with the Budget and Finance
20 Committee on these recommendations.
