

22 and Finance Committee concerning the budget in accordance with the annual  
23 budget instructions. 12 N.N.C. § 840 (A).  
24 C. The Budget and Finance Committee has oversight of the Office of Management  
25 and Budget. 12 N.N.C. §301(B)(13).

27 **SECTION TWO. FINDINGS**

- 28 A. The Budget and Finance Committee held a hearing and took budget testimony  
29 regarding the Office of Management and Budget, Fiscal Year 2020 Budget. 12  
30 N.N.C. § 840 (A).

1 B. The Budget and Finance Committee recommends a fiscal year budget for the Office  
2 of the Controller. 12 N.N.C. § 840 (A).

14 incorporated into the Navajo Nation Comprehensive Budget.
