17 **SECTION ONE. AUTHORITY**

- 18 A. The Law and Order Committee is a standing committee of the Navajo Nation

20 B. The Law and Order Committee is the oversight committee for the Navajo Nation  
21 Office of Ethics and Rules. 2 N.N.C. § 601(C)(1).  
22 C. Each oversight committee shall review and make recommendations to the Budget  
23 and Finance Committee concerning the budget in accordance with the annual  
24 budget instructions. 12 N.N.C. § 840 (A).

26 **SECTION TWO. FINDINGS**

- 27 A. The Law and Order Committee held a budget hearing and took budget testimony  
28 regarding the Navajo Nation Office of Ethics and Rules Fiscal Year 2020 Budget.

16 General Fund Budget, **Exhibit C**, Recommended Conditions of Appropriation and  
17 Legislative Concerns, **Exhibit D**, and Recommended Unmet Needs, **Exhibit E**.

18 C. The Law and Order Committee authorizes the Committee Chairperson or Vice-  
19 Chairperson to meet and negotiate with the Budget and Finance Committee on these  
20 recommendations.
