BE IT ENACTED:

**SECTION ONE. AUTHORITY**

- A. The Resources and Development Committee is a standing committee of the Navajo Nation Council. 2 N.N.C. § 500(A).
- B. The Resources and Development Committee is the oversight committee for the Environmental Protection Agency. 2 N.N.C. § 501(C)(1).
- C. Each oversight committee shall review and make recommendations to the Budget and Finance Committee concerning the budget in accordance with the annual budget instructions. 12 N.N.C. § 840 (A).

**SECTION TWO. FINDINGS**

- A. The Resources and Development Committee held a budget hearing and took budget testimony regarding the Navajo Nation Environmental Protection Agency's Fiscal Year 2020 Budget. 12 N.N.C. § 840 (A).

12 on the Fund Type Budget Summary, attached as **Exhibit A**.

13 B. The Resources and Development Committee requests that the Budget and Finance  
14 Committee and the Navajo Nation Council adopt the changes to the Budget, as set  
15 forth in the General Fund Comparative Summary, **Exhibit B**, Recommended Changes  
16 to the General Fund Budget, **Exhibit C**, Recommended Conditions of Appropriation  
17 and Legislative Concerns, **Exhibit D**, and Recommended Unmet Needs, **Exhibit E**.

18 C. The Resources and Development Committee authorizes the Committee Chairperson  
19 or Vice-Chairperson to meet and negotiate with the Budget and Finance Committee  
20 on these recommendations.
