21 Division of Community Development. 2 N.N.C. § 501(C)(1).
22 C. Each oversight committee shall review and make recommendations to the Budget
23 and Finance Committee concerning the budget in accordance with the annual
24 budget instructions. 12 N.N.C. § 840 (A).

- 27 A. The Resources and Development Committee held a budget hearing and took
28 budget testimony regarding the Navajo Nation Division of Community

13 B. The Resources and Development Committee requests that the Budget and Finance
14 Committee and the Navajo Nation Council adopt the changes to the Budget, as set
15 forth in the General Fund Comparative Summary, **Exhibit B**, Recommended Changes
16 to the General Fund Budget, **Exhibit C**, Recommended Conditions of Appropriation
17 and Legislative Concerns, **Exhibit D**, and Recommended Unmet Needs, **Exhibit E**.

18 C. The Resources and Development Committee authorizes the Committee Chairperson
19 or Vice-Chairperson to meet and negotiate with the Budget and Finance Committee
20 on these recommendations.
