

16 **Section One. Authority**

- 17 A. The Resources and Development Committee and the Budget and Finance
18 Committee (BFC) are standing committees of the Navajo Nation Council. 2
19 N.N.C. § 500(A) and 300(A).
20 B. The Resources and Development Committee has oversight of the Division of
21 Natural Resources, Parks and Recreation Department. 2 N.N.C. § 501(C)(1).
22 C. The BFC is empowered to approve fund management plans upon the
23 recommendation of the appropriate oversight committee and the affected division
24 or branch. 2 N.N.C. § 301(B)(14).

26 **Section Two. Findings**

- 27 A. The Plan of Operation for the Navajo Nation Division of Natural Resources Parks
28 and Recreation Department was amended through Resolution RDCJY-31-19. The
29 amendment removed the planning and undertaking of the Navajo Nation Fair and
30 Fourth of July Celebration. See RDCJY-31-19.

- 1 B. The Navajo Nation Division of Natural Resources Parks and Recreation
2 Department Plan of Operation as amended through Resolution RDCJY-31-19
3 necessitate amendments to the Navajo Parks and Recreation Department Enterprise
4 Fund Management Plan as approved through BFAU-41-05. BFAU-41-05 is
5 attached as **Exhibit B**.
- 6 C. The proposed amendments to the Navajo Parks and Recreation Department
7 Enterprise Fund Management Plan are attached as **Exhibit A**.
- 8 D. The Executive Review Document No. 012996 as reviewed by the Navajo
9 Department of Justice is attached as **Exhibit C**.
