
This written summary does not address recommended amendments as may be provided by the standing committees. The Office of Legislative Counsel requests each Council Delegate review the proposed resolution in detail.

15 **Section One. Authority**

- 16 A. The Navajo Nation established the Naabik'iyáti' Committee as a Navajo Nation
17 Council standing committee. 2 N.N.C. § 700 (A) (2012) *see also* CJA-03-13.
18 B. The Naabik'iyáti' Committee exercises legislative oversight of the Diné Uranium
19 Remediation Advisory Commission with the authority to approve amendments to the
20 Diné Uranium Remediation Advisory Commission's Master Plan of Operation. 2
21 N.N.C. § 3584. *See also* CAP-14-15.

22 **Section Two. Findings**

- 23 A. The Navajo Nation Council amended the Navajo Nation Code at 2 N.N.C. § 3580 to
24 establish the Diné Uranium Remediation Advisory Commission. *See* Exhibit A-
25 CAP-14-15.
26 B. Pursuant to CAP-14-15 and 2 N.N.C. § 3582, the organization of the Navajo Nation
27 Uranium Remediation Advisory Commission shall be set forth in the Master Plan of
28 Operation adopted by the Naabik'iyáti' Committee of the Navajo Nation Council.

- 1 C. The Naabik'iyáti' Committee adopted the Master Plan of Operation of the Diné
2 Uranium Remediation Advisory Commission through NABIAU-52-15 attached as
3 Exhibit B.
- 4 D. The Navajo Nation Council amended the Master Plan of Operation of the Diné
5 Uranium Remediation Advisory Commission through CJA-14-17 attached as Exhibit
6 C.
- 7 E. The Diné Uranium Remediation Advisory Commission Plan of Operation shall be
8 amended by the Navajo Nation Council upon the recommendation of the
9 Naabik'iyáti' Committee. See Exhibit C, Master Plan of Operation Section XVII.
- 10 F. The Diné Uranium Remediation Advisory Commission has requested approval of an
11 Amended Master Plan of Operation for 2019. See Exhibit D.
- 12 G. The Navajo Nation Council finds it to be in the best interest of the Diné to approve
13 the Amended Master Plan of Operation for 2019 as requested by the Commission and
14 as found at Exhibit D.

16 **Section Three. Approval.**

17 The Navajo Nation hereby approves the Amended Master Plan of Operation for 2019
18 as requested and submitted by the Diné Uranium Remediation Advisory Commission
19 and as found at Exhibit D.
