
PURPOSE: Approving a mission site permit for The Door Church located in the Shiprock Chapter.

15 **Section One. Authority**

- 16 A. Pursuant to 16 N.N.C. Section 1151 (C), the Resources Development Committee of
17 the Navajo Nation Council has the authority to give approval for permits for mission
18 sites on behalf of the Navajo Nation.
- 19 B. Pursuant to 2 N.N.C. Section 501 (B)(2), the Resources Development Committee of
20 the Navajo Nation Council has the authority to give final approval for all land
21 withdrawals, non-mineral leases, permits, licenses, rights-of-way, surface easements
22 and bonding requirements on Navajo Nation lands and unrestricted (fee) land. This
23 authority shall include subleases, modifications, assignments, leasehold
24 encumbrances, transfers, renewals, and terminations.

26 **Section Two. Findings**

- 27 A. The Door Church, P.O. Box 3527, Shiprock, New Mexico 87420 has applied for a
28 mission site permit within the Shiprock Chapter. The application is attached as
29 **Exhibit E.**

- 1 B. The proposed mission site is to be located on 1.5 acres, more or less, of trust lands
2 within the vicinity of Shiprock Chapter, Navajo Nation (New Mexico). The land
3 description appears on the survey plat attached hereto and incorporated as **Exhibit B**.
- 4 C. The Grazing Committee Representative has declared that the land is designated for
5 community development and is not on grazing land. See **Exhibit C**.
- 6 D. The Shiprock Chapter Resolution No. 03-29-15-028-SHIP supporting the Door
7 Church application for a mission site permit and the signed petition by the local
8 residents in support of the Door Church are attached as **Exhibit D**.
- 9 E. The Terms and Conditions for the Mission Site Permit is attached as **Exhibit A**.
- 10 F. The Cultural Resources Compliance Form, the Archaeological Inventory Report, the
11 Environmental Investigation Report, the Navajo Nation Environmental Protection
12 Agency's Public Water Systems Supervision Program memorandum, the
13 Environmental Department Air & Toxics Department memorandum, for The Door
14 Church are attached as **Exhibit F**.
- 15 G. The application for mission site permit has been reviewed through the Executive
16 Official Review Document No. 010595, including the Department of Justice, and
17 found "Sufficient" or "Approved." Executive Official Review Document No.
18 010595 is attached as **Exhibit G**.

20 **Section Four. Approval**

- 21 A. The Resources and Development Committee of the Navajo Nation Council hereby
22 approves the Mission Site Permit for The Door Church, subject to but not limited to
23 the attached Terms and Conditions contained herein as **Exhibit A** and located on land
24 described in Exhibit B, which are attached hereto and incorporated herein by this
25 reference.
- 26 B. The Resources and Development Committee of the Navajo Nation Council hereby
27 authorizes President of the Navajo Nation to execute all documents to affect the
28 intent and purpose of this resolution.
