BE IT ENACTED:

Section One. Authority

1. The Resources and Development Committee exercises authority over chapters of the Navajo Nation. 2 N.N.C. § 501(C)(1).
2. The Budget and Finance Committee of the Navajo Nation Council exercises authority over budgeting, appropriation, investment and management of all funds. 2 N.N.C. § 301 (B)(2).
3. Council Resolution CAP-35-18 provides, “[a] chapter project, powerline, or waterline project may be changed, including the year funded, or added to Exhibits A through E with the concurrence of the Delegate representing the chapter’s Council District and the approvals of the Resources and Development Committee and Budget and Finance Committee, as long as such project has been certified as

1 construction-ready by CPMD or NTUA and the total Sihasin Funding for the
2 District does not exceed \$4,166,666.67.” **Exhibit 1**, Section Four, Paragraph C.

4 **Section Two. Findings**

- 5 A. The Navajo Nation Council adopted Council Resolution CAP-35-18, “Adopting the
6 Sihasin Fund Powerline and Chapter Projects Expenditure Plan Pursuant to CD-68-14,
7 as Amended by CJA-03-18, and 12 N.N.C. §§ 2501-2508, as Amended; Waiving 12
8 N.N.C. §§ 810 (F), 820 (I) and (M) and 860 (C) Relating to the Capital Budget and
9 Capital Improvement Process” on April 17, 2018, which is attached as **Exhibit 1**.
- 10 B. Low Mountain Chapter submitted a CAP-35-18 Project Change Form, which is attached
11 as **Exhibit 2**. For reference, the Low Mountain project is included in **Exhibit 1**, Exhibit
12 D, Project 9.
- 13 C. Low Mountain Chapter submitted chapter resolutions, which are included in **Exhibit 3**,
14 indicating its support for this request.
- 15 D. Low Mountain Chapter requests to change the project from a Head Start facility to the
16 planning and designing of a Head Start Facility and the planning and designing of a
17 multi-purpose facility.

20 The Navajo Nation hereby approves the project changes requested by Low Mountain
21 Chapter in accordance with **Exhibit 2**.
