

15 **SECTION ONE. AUTHORITY**

16 A. The Navajo Nation Council is the governing body of the Navajo Nation. 2 N.N.C. § 102

17 (A).

18 B. A proposed resolution requiring final action by the Navajo Nation Council shall be
19 assigned to the Naabik'iyáti' Committee. 2 N.N.C. §501(C)(1).

21 **SECTION TWO. FINDINGS**

22 A. The Navajo Nation President has the authority to appoint a person to serve as the
23 Executive Director of the Division of General Services, with confirmation by the
24 Navajo Nation Council. 2 N.N.C. §1253.

25 B. The appointed Executive Director of the Division of General Services serves at the
26 pleasure of the Navajo Nation President. 2 N.N.C. §1253.

27 C. The Navajo Nation President has appointed Tom Platero as the Executive Director of
28 the Division of General Services. Mr. Platero's appointment letter is attached as
29 **Exhibit A.**

1 D. Given his background and experience working for the Navajo Nation, Mr. Tom Platero
2 is highly qualified to serve as the Executive Director of the Division of General
3 Services. Mr. Platero's résumé and references are attached as **Exhibit B**.

4 E. The Navajo Nation President believes it in the best interest of the Navajo Nation for
5 Tom Platero's appointment to be confirmed by the Navajo Nation.
