**PURPOSE:** This resolution, if adopted, would amend HEHSCD-042-13, Policy Manual For Low Income Home Energy Assistance Program.



**BE IT ENACTED:**

**SECTION ONE. AUTHORITY**

The Health, Education and Human Services Committee is a standing committee of the Navajo Nation Council. 2 N.N.C. § 400(A). Among various responsibilities, it serves as oversight authority for the Navajo Nation Division of Social Services. 2 N.N.C. § 401(C)(1).

**SECTION TWO. FINDINGS**

A. The Navajo Nation Division of Social Services is proposing amendments to the Policy Manual for the Low Income Home Energy Assistance Program. See attached Exhibit A-1.

1 B. The Navajo Nation Department of Justice has reviewed the proposed amendments to  
2 the Policy Manual for the Low Income Home Energy Assistance Program. See attached

4 C. The Policy Manual was approved by HEHSCD-042-13. See attached Exhibit C.

6 **SECTION THREE. APPROVING AMENDMENTS TO HEHSCD-042-13 AND**  
7 **THE POLICY MANUAL FOR LOW INCOME HOME ENERGY ASSISTANCE**

8 A. The Health, Education and Human Services Committee of the Navajo Nation Council  
9 hereby amends HEHSCD-042-13 and the Policy Manual for Low Income Home Energy  
10 Assistance program as provided in Exhibit A-1 attached hereto.

11 B. The Navajo Nation Division of Social Services shall ensure compliance with the  
12 Navajo Nation Privacy Act, 2 N.N.C. § 81 *et seq*, in providing services under the Policy  
13 Manual for the Low Income Home Energy Assistance program.
