

19 **SECTION ONE. AUTHORITY**

- 20 A. The Health, Education, and Human Services Committee serves as the oversight
21 committee for the Division of General Services. 2 N.N.C. §701(A)(5).
- 22 B. The Budget Instruction Manual defines a budget reallocation as “the reallocation of
23 funds between business units which requires oversight approval. Navajo Nation
24 Budget Instruction Manual, FY 2021 XI.C.2.
- 25 C. A standing committee may reallocate funds appropriated by the Navajo Nation Council
26 to a division or program over which the committee has oversight. 2 N.N.C. §185(A).
- 27 D. A reallocation of funds must be approved “by two-thirds (2/3) vote of the full
28 membership of the committee, board or commission.” 2 N.N.C. §185(A).

30 **SECTION TWO. FINDINGS**

- 1 A. The Division of General Services is requesting a reallocation of funds in the amount
2 of \$124,350 from the Business Unit Numbers 112001, 112006, 112008, and 112009
3 to Business Unit 112010. The Budget Revision Request is attached are **Exhibit A**.
4 B. The budget reallocation is requested to provide sufficient funding for the Records
5 Management Department. The reallocation will ensure the continued operations of
6 the Records Management Department through Fiscal Year 2021.
7 C. The Executive Branch Section 164 review has been reviewed by OMB, OOC, and
8 DOJ, and is attached as **Exhibit B**.

10 **SECTION THREE. APPROVAL OF REALLOCATION**

- 11 A. The Health, Education and Human Services Committee approves the budget
12 reallocation in the total amount of \$124,350 from Business Unit Numbers 112001,
13 112006, 112008, and 112009 to Business Unit 112010 in accordance with the Budget
14 Revision Requests in **Exhibit A**.
