20 Judicial Branch 2 N.N.C. § 601(C)(1).
21 C. Each oversight committee shall review and make recommendations to the Budget
22 and Finance Committee concerning the budget in accordance with the annual
23 budget instructions. 12 N.N.C. § 840 (A).

15 Chairperson to meet and negotiate with the Budget and Finance Committee on
16 these recommendations.
