BE IT ENACTED:

SECTION ONE. AUTHORITY

- A. The Resources and Development Committee is a standing committee of the Navajo Nation Council. 2 N.N.C. § 500(A).
- B. The Resources and Development Committee is the oversight committee for the Division of Economic Development. 2 N.N.C. § 501(C)(1).
- C. Each oversight committee shall review and make recommendations to the Budget and Finance Committee concerning the budget in accordance with the annual budget instructions. 12 N.N.C. § 840 (A).

SECTION TWO. FINDINGS

- A. The Resources and Development Committee held a budget hearing and took budget testimony regarding the Navajo Nation Division of Economic Development's Fiscal Year 2022 Budget. 12 N.N.C. § 840 (A).

16 Changes to the General Fund Budget, **Exhibit C**, Recommended Conditions of
17 Appropriation and Legislative Concerns, **Exhibit D**, and Recommended Unmet
18 Needs, **Exhibit E**.
19 C. The Resources and Development Committee authorizes the Committee
20 Chairperson or Vice-Chairperson to meet and negotiate with the Budget and
21 Finance Committee on these recommendations.
