20 for the Navajo Nation Division of Social Services. 2 N.N.C. § 401(C)(1).
21 C. Each oversight committee shall review and make recommendations to the Budget
22 and Finance Committee concerning the budget in accordance with the annual
23 budget instructions. 12 N.N.C. § 840 (A).

10 proposed Navajo Nation Fiscal Year 2022 Budget for the Navajo Nation Division
11 of Social Services, recommended by the President of the Navajo Nation, as
12 provided on the Fund Type Budget Summary, attached as **Exhibit A**.

13 B. The Health, Education and Human Services Committee requests that the Budget
14 and Finance Committee and the Navajo Nation Council adopt the changes to the
15 Budget, as set forth in the General Fund Comparative Summary, **Exhibit B**,
16 Recommended Changes to the General Fund Budget, **Exhibit C**, Recommended
17 Conditions of Appropriation and Legislative Concerns, **Exhibit D**, and
18 Recommended Unmet Needs, **Exhibit E**.

19 C. The Health, Education and Human Services Committee authorizes the Committee
20 Chairperson or Vice-Chairperson to meet and negotiate with the Budget and
21 Finance Committee on these recommendations.
