

**This written summary does not address recommended amendments as may be provided by the standing committee. The Office of Legislative Counsel requests each committee member to review the proposed resolution in detail.**



16 **SECTION ONE. AUTHORITY**

18 Nation Council. 2 N.N.C. § 500(A).  
19 B. The Resources and Development Committee is the oversight committee for the  
20 Division of Transportation. 2 N.N.C. § 501(C)(1).  
21 C. Each oversight committee shall review and make recommendations to the Budget  
22 and Finance Committee concerning the budget in accordance with the annual  
23 budget instructions. 12 N.N.C. § 840 (A).

25 **SECTION TWO. FINDINGS**

- 26 A. The Resources and Development Committee held a budget hearing and took budget  
27 testimony regarding the Navajo Nation Division of Transportation's Fiscal Year  
28 2022 Budget. 12 N.N.C. § 840 (A).

11 Transportation, recommended by the President of the Navajo Nation, as provided on  
12 the Fund Type Budget Summary, attached as **Exhibit A**.

13 B. The Resources and Development Committee requests that the Budget and Finance  
14 Committee and the Navajo Nation Council adopt the changes to the Budget, as set  
15 forth in the General Fund Comparative Summary, **Exhibit B**, Recommended  
16 Changes to the General Fund Budget, **Exhibit C**, Recommended Conditions of  
17 Appropriation and Legislative Concerns, **Exhibit D**, and Recommended Unmet  
18 Needs, **Exhibit E**.

19 C. The Resources and Development Committee authorizes the Committee Chairperson  
20 or Vice-Chairperson to meet and negotiate with the Budget and Finance Committee  
21 on these recommendations.
