

BE IT ENACTED:

**SECTION ONE. AUTHORITY**

- A. The Health, Education and Human Services Committee is a standing committee of the Navajo Nation Council. 2 N.N.C. § 400(A).
- B. The Health, Education and Human Services Committee is the oversight committee for the Navajo Nation Department of Diné Education. 2 N.N.C. § 401(C)(1).
- C. Each oversight committee shall review and make recommendations to the Budget and Finance Committee concerning the budget in accordance with the annual budget instructions. 12 N.N.C. § 840 (A).

**SECTION TWO. FINDINGS**

- A. The Health, Education and Human Services Committee held a budget hearing and took budget testimony regarding the Navajo Nation Department of Diné Education' Fiscal Year 2022 Budget. 12 N.N.C. § 840 (A).

1 B. The Health, Education and Human Services Committee recommends to the Budget  
2 and Finance Committee a fiscal year budget for the Navajo Nation Department of  
3 Diné Education. 12 N.N.C. § 840 (A).

9 A. The Health, Education and Human Services Committee hereby acknowledges the  
10 proposed Navajo Nation Fiscal Year 2022 Budget for the Navajo Nation  
11 Department of Diné Education, recommended by the Office of Navajo Nation  
12 President and Vice President, as provided on the Fund Type Budget Summary,  
13 attached as **Exhibit A**.

14 B. The Health, Education and Human Services Committee requests that the Budget  
15 and Finance Committee and the Navajo Nation Council adopt the changes to the  
16 Budget, as set forth in the General Fund Comparative Summary, **Exhibit B**,  
17 Recommended Changes to the General Fund Budget, **Exhibit C**, Recommended  
18 Conditions of Appropriation and Legislative Concerns, **Exhibit D**, and  
19 Recommended Unmet Needs, **Exhibit E**.

20 C. The Health, Education and Human Services Committee authorizes the Committee  
21 Chairperson or Vice-Chairperson to meet and negotiate with the Budget and  
22 Finance Committee on these recommendations.
