BE IT ENACTED:

**SECTION ONE. AUTHORITY**

- A. The Health, Education and Human Services Committee is a standing committee of the Navajo Nation Council. 2 N.N.C. § 400(A).
- B. The Health, Education and Human Services Committee is the oversight committee for the Navajo Nation Veterans Administration. 2 N.N.C. § 401(C)(6).
- C. Each oversight committee shall review and make recommendations to the Budget and Finance Committee concerning the budget in accordance with the annual budget instructions. 12 N.N.C. § 840 (A).

**SECTION TWO. FINDINGS**

- A. The Health, Education and Human Services Committee held a budget hearing and took budget testimony regarding the Navajo Nation Veterans Administration? Fiscal Year 2022 Budget. 12 N.N.C. § 840 (A).

1 B. The Health, Education and Human Services Committee recommends to the Budget  
2 and Finance Committee a fiscal year budget for the Navajo Nation Veterans

15 Budget, as set forth in the General Fund Comparative Summary, **Exhibit B**,  
16 Recommended Changes to the General Fund Budget, **Exhibit C**, Recommended  
17 Conditions of Appropriation and Legislative Concerns, **Exhibit D**, and  
18 Recommended Unmet Needs, **Exhibit E**.

19 C. The Health, Education and Human Services Committee authorizes the Committee  
20 Chairperson or Vice-Chairperson to meet and negotiate with the Budget and  
21 Finance Committee on these recommendations.
