

16 SECTION ONE. AUTHORITY

- 17 A. The Health, Education and Human Services Committee is a standing committee of  
18 the Navajo Nation Council. 2 N.N.C. § 400(A).  
19 B. The Health, Education and Human Services Committee is the oversight committee  
20 for the Navajo Nation Department of Health. 2 N.N.C. § 401(C)(1).  
21 C. Each oversight committee shall review and make recommendations to the Budget  
22 and Finance Committee concerning the budget in accordance with the annual  
23 budget instructions. 12 N.N.C. § 840 (A).

25 SECTION TWO. FINDINGS

- 26 A. The Health, Education and Human Services Committee held a budget hearing and  
27 took budget testimony regarding the Navajo Nation Department of Health's Fiscal  
28 Year 2022 Budget. 12 N.N.C. § 840 (A).

1 B. The Health, Education and Human Services Committee recommends to the Budget  
2 and Finance Committee a fiscal year budget for the Navajo Nation Department of

10 proposed Navajo Nation Fiscal Year 2022 Budget for the Navajo Nation  
11 Department of Health, recommended by the President of the Navajo Nation, as  
12 provided on the Fund Type Budget Summary, attached as **Exhibit A**.

13 B. The Health, Education and Human Services Committee requests that the Budget  
14 and Finance Committee and the Navajo Nation Council adopt the changes to the  
15 Budget, as set forth in the General Fund Comparative Summary, **Exhibit B**,  
16 Recommended Changes to the General Fund Budget, **Exhibit C**, Recommended  
17 Conditions of Appropriation and Legislative Concerns, **Exhibit D**, and  
18 Recommended Unmet Needs, **Exhibit E**.

19 C. The Health, Education and Human Services Committee authorizes the Committee  
20 Chairperson or Vice-Chairperson to meet and negotiate with the Budget and  
21 Finance Committee on these recommendations.
