

19 B. The Law and Order Committee is the oversight committee for the Navajo Nation  
20 Office of Hearings and Appeals 2 N.N.C. § 601(C)(1).  
21 C. Each oversight committee shall review and make recommendations to the Budget  
22 and Finance Committee concerning the budget in accordance with the annual  
23 budget instructions. 12 N.N.C. § 840 (A).

25 **SECTION TWO. FINDINGS**

- 26 A. The Law and Order Committee held a budget hearing and took budget testimony  
27 regarding the Navajo Nation Office of Hearings and Appeals' Fiscal Year 2022

13 B. The Law and Order Committee requests that the Budget and Finance Committee  
14 and the Navajo Nation Council adopt the changes to the Budget, as set forth in the  
15 General Fund Comparative Summary, **Exhibit B**, Recommended Changes to the  
16 General Fund Budget, **Exhibit C**, Recommended Conditions of Appropriation and  
17 Legislative Concerns, **Exhibit D**, and Recommended Unmet Needs, **Exhibit E**.

18 C. The Law and Order Committee authorizes the Committee Chairperson or Vice-  
19 Chairperson to meet and negotiate with the Budget and Finance Committee on  
20 these recommendations.
