16 **SECTION ONE. AUTHORITY**

- 17 A. The Naabik'iyáti' Committee is a standing committee of the Navajo Nation
18 Council. 2 N.N.C. § 700(A).
19 B. The Naabik'iyáti' Committee is the oversight committee for the Navajo Nation
20 Executive Offices. 12 N.N.C. § 840(A).
21 C. Each oversight committee shall review and make recommendations to the Budget
22 and Finance Committee concerning the budget in accordance with the annual
23 budget instructions. 12 N.N.C. § 840 (A).

25 **SECTION TWO. FINDINGS**

- 26 A. The Naabik'iyáti' Committee held a budget hearing and took budget testimony
27 regarding the Navajo Nation Executive Office's Fiscal Year 2022 Budget. 12
28 N.N.C. § 840 (A).
29 B. The Naabik'iyáti' Committee recommends to the Budget and Finance Committee
30 a fiscal year budget for the Navajo Nation Executive Offices. 12 N.N.C. § 840 (A).

6 Year (FY) 2022 Budget for the Navajo Nation Executive Offices, recommended by
7 the President of the Navajo Nation, as provided on the Fund Type Budget
8 Summary, attached as **Exhibit A**.

9 B. The Naabik'íyáti' Committee requests that the Budget and Finance Committee and
10 the Navajo Nation Council adopt the changes to the Budget, as set forth in the
11 General Fund Comparative Summary **Exhibit B**, Recommended Changes to the
12 General Fund Budget, **Exhibit C**, Recommended Conditions of Appropriation and
13 Legislative Concerns, **Exhibit D**, and Recommended Unmet Needs, **Exhibit E**.

14 C. The Naabik'íyáti' Committee authorizes the Committee Chairman to meet and
15 negotiate with the Budget and Finance Committee on these recommendations.
