

16 **SECTION ONE. AUTHORITY**

- 17 A. The Naabik'iyáti' Committee is a standing committee of the Navajo Nation
18 Council. 2 N.N.C. § 700(A).
19 B. The Naabik'iyáti' Committee is the oversight committee for the Office of
20 Legislative Services and other offices, programs, commissions, boards or task
21 forces under the Legislative Branch and the Naabik'iyáti' Committee has the power
22 to prepare and recommend approval of a Committee budget each fiscal year. 2
23 N.N.C. §§ 701(A)(5) , 701 A(13).
24 C. Each oversight committee shall review and make recommendations to the Budget
25 and Finance Committee concerning the budget in accordance with the annual
26 budget instructions. 12 N.N.C. § 840 (A).

28 **SECTION TWO. FINDINGS**

1 A. The Naabik'íyáti' Committee held a budget hearing and took budget testimony
2 regarding the Navajo Nation Legislative Branch Fiscal Year 2020 Budget. 12
3 N.N.C. § 840 (A).

4 B. The Naabik'íyáti' Committee recommends to the Budget and Finance Committee
5 a fiscal year budget for the Navajo Nation Legislative Branch. 12 N.N.C. § 840
6 (A).

8 **SECTION THREE. APPROVING AND RECOMMENDING TO THE BUDGET**
9 **AND FINANCE COMMITTEE THE PROPOSED FISCAL YEAR 2022 BUDGET**
10 **FOR THE NAVAJO NATION LEGISLATIVE BRANCH**

11 A. The Naabik'íyáti' Committee hereby approves the proposed Navajo Nation Fiscal
12 Year (FY) 2022 Budget for the Navajo Nation Legislative Branch, recommended
13 by the Speaker of the Navajo Nation, as provided on the Fund Type Budget
14 Summary, attached as **Exhibit A**.

15 B. The Naabik'íyáti' Committee recommends that the Budget and Finance Committee
16 and the Navajo Nation Council adopt the changes to the Budget, as set forth in the
17 General Fund Comparative Summary **Exhibit B**, Recommended Changes to the
18 General Fund Budget, **Exhibit C**, Recommended Conditions of Appropriation and
19 Legislative Concerns, **Exhibit D**, and Recommended Unmet Needs, **Exhibit E**.

20 C. The Naabik'íyáti' Committee authorizes the Committee Chairperson to meet and
21 negotiate with the Budget and Finance Committee on these recommendations.
