21 the Native American Housing Assistance and Self-Determination Act of 1996  
22 (NAHASDA) Indian Housing Plan. 2 N.N.C. § 501 (B) (2) (b).

24 SECTION TWO. FINDINGS

25 The Board of Commissioners of the Navajo Housing Authority, by Resolution NHA-5067-  
26 2021, attached hereto as **Exhibit B**, requests the support and endorsement of the Resources  
27 and Development Committee of the Navajo Nation Council to approve the Fiscal Year 2021  
28 American Rescue Plan Act of 2021 from the Native American Housing Assistance and Self-  
29 Determination Act of 1996 (NAHASDA) Indian Housing Block Grant Funding and to

1 authorize the submission of the Navajo Nation Indian Housing Plan by the Navajo Housing  
2 Authority on behalf of the Navajo Nation.

4 **SECTION THREE. APPROVAL**

5 A. The Resources and Development Committee of the Navajo Nation Council hereby  
6 approves the Fiscal Year 2021 American Rescue Plan Act of 2021 from the Native  
7 American Housing Assistance and Self-Determination Act of 1996 (NAHASDA)
