**BE IT ENACTED:**

**Section One. Authority**

A. The Navajo Nation Council established the Health, Education and Human Services Committee as a Navajo Nation Standing Committee. 2 N.N.C. §400(A).

**Section Two. Findings**

- A. The Health, Education and Human Services Committee shall consist of six members. 2 N.N.C. § 400 (B).
- B. The Health, Education and Human Services Committee shall select a Chairperson and Vice-Chairperson by a vote. 2 N.N.C. § 184 (A).

**Section Three. Confirming Chairperson and Vice-Chairperson**
