
PURPOSE: The purpose of the resolution is to confirm Tico Charlee as the Executive Director of the Navajo Telecommunications Regulatory Commission.

BE IT ENACTED:

Section One. Authority

- A. The Resources and Development Committee of the Navajo Nation Council has oversight authority with respect to communications and utilities. 2 N.N.C. § 500(C).
- B. The Naabik'iyáti' Committee confirms the appointment of the Navajo Telecommunications Regulatory Commission Executive Director. 2 N.N.C. §3455 *see also* CO-45-12 sec. 5(A) and 2 N.N.C. §701(A)(1).

Section Two. Findings

- A. The President of the Navajo Nation shall employ an Executive Director of the Commission who shall serve at the pleasure of the President of the Navajo Nation and be subject to confirmation by the [Naabik'iyáti'] Committee of the Navajo Nation Council. All other staff shall be employed by the Executive Director in accordance with Personnel Policies Manual of the Navajo Nation. 2 N.N.C. §3455 and CO-45-12 sec. 5(A).
