**SECTION ONE. AUTHORITY**

- A. The Navajo Nation Council is the governing body of the Navajo Nation and shall confirm the appointments of all division directors upon recommendation from the appropriate oversight committee. 2 N.N.C. §§ 102 (A) and (F).
- B. A proposed resolution requiring final action by the Navajo Nation Council shall be assigned to the Naabik'iyáti' Committee. 2 N.N.C. §164(A)(9).
- C. The Resources and Development Committee is a standing committee of the Navajo Nation Council with oversight authority over the Division of Community Development. 2 N.N.C. § 501 (C)(1).

**SECTION TWO. FINDINGS**

- A. The Navajo Nation Code provides, that the Navajo Division of Community Development “shall be administered by a Division Director, who shall be appointed by the President of the Navajo Nation, confirmed by the Navajo Nation Council, and who shall serve at the pleasure of the Navajo Nation.” 2 N.N.C. §1453(A).

1 B. The Navajo Nation President appoints Calvin Castillo as the Division Director for the  
2 Division of Community Development. Calvin Castillo's appointment letter and resume  
3 are attached as **Exhibit A**.

6 The Navajo Nation Council confirms the Navajo Nation President's appointment of Calvin  
7 Castillo as the Division Director for the Division of Community Development.
