18 SECTION ONE. AUTHORITIES

- 19 A. The Navajo Nation Council is the governing body of the Navajo Nation and shall
- 20 confirm the appointments of all division directors upon recommendation from the
- 21 appropriate oversight committee. 2 N.N.C. §§ 102 (A) and (F).
- 22 B. A proposed resolution requiring final action by the Navajo Nation Council shall be
- 23 assigned to the Naabik'iyáti' Committee. 2 N.N.C. §164(A)(9).
- 24 C. The Resources and Development Committee is a standing committee of the Navajo
- 25 Nation Council with oversight authority over the Division of Natural Resources and
- 26 the responsibility to recommend the appointment of the Executive Director of the
- 27 Division of Natural Resources to the Navajo Nation Council. 2 N.N.C. §§ 501 (C)(1)
- 28 and 1905.
- 29 D. The Navajo Nation President appoints the Executive Director of the Navajo Nation
- 30 Division of Natural Resources. 2 N.N.C. § 1903.

1 E. The appointed Executive Director serves at the pleasure of the Navajo Nation
2 President, *id.*, and shall fulfill the purposes for the Division of Natural Resources set
3 forth at 2 N.N.C. § 1902.

5 **SECTION TWO. APPOINTMENT OF THE NAVAJO NATION DIVISION OF**
6 **NATURAL RESOURCES EXECUTIVE DIRECTOR**

7 The Navajo Nation President appoints Wilder Mike Halona as the Navajo Nation
8 Division of Natural Resources Executive Director. Mr. Halona's appointment letter and
9 credentials attached as **Exhibit A**.

11 **SECTION THREE. CONFIRMATION OF THE NAVAJO NATION DIVISION OF**
12 **NATURAL RESOURCES EXECUTIVE DIRECTOR**

13 A. The Navajo Nation Council confirms Wilder Mike Halona as the Navajo Nation
14 Division of Natural Resources Executive Director.
