17 **BE IT ENACTED:**

19 **SECTION ONE. AUTHORITY**

20 A. The Resources and Development Committee of the Navajo Nation Council has  
21 oversight authority over housing for the purpose of establishing policies and  
22 legislation appropriate to the housing needs of the Navajo Nation and its People. 2  
23 N.N.C. § 500(C)(3).

25 **SECTION TWO. FINDINGS**

26 A. Pursuant to 6 N.N.C. § 606 (A), the Navajo Nation Council provided that a  
27 Nominations Committee (“Nominations Committee”) would appoint members to  
28 the Navajo Housing Authority Board of Commissioners. CJA-13-17 is attached as  
29 **Exhibit A.**

1 B. The Nominations Committee is to be “composed of the Navajo Nation President,  
2 Speaker of the Navajo Nation Council, [and a] Resources Development Committee  
3 designee....” 6 N.N.C. § 606 (A).

4 C. The Resources and Development Committee designee is an integral part of  
5 Nominations Committee and it is in the best interest of the Navajo Nation to select  
6 the Resources and Development Committee designee.

8 **SECTION THREE. APPROVAL OF RESOURCES AND DEVELOPMENT**

9 **COMMITTEE DESIGNEE**

10 A. The Resources and Development Committee hereby selects Resources and  
11 Development Committee Delegate \_\_\_\_\_ to serve as  
12 the Resources and Development Committee designee for the Nominations  
13 Committee of the Navajo Housing Authority Board of Commissioners.

14 B. The Resources and Development Committee designee shall serve for the duration of  
15 the term of the 25<sup>th</sup> Navajo Nation Council.
