PURPOSE: This resolution, if approved, will appoint the Speaker of the 25th Navajo Nation Council's Appointments of Delegate Members to the Naabik'iyáti' State Task Force Subcommittee.

This written summary does not address recommended amendments as may be provided by the standing committee. The Office of Legislative Counsel requests each Council Delegate to review the proposed resolution in detail.

17 BE IT ENACTED:

19 SECTION ONE. AUTHORITY

20 A. The Naabik'iyáti' Committee is established as a standing committee of the Navajo
21 Nation Council. 2 N.N.C. §700(A).

23 SECTION TWO. FINDINGS

24 A. The Naabik'iyáti' Committee of the Navajo Nation Council established the
25 Naabik'iyáti' State Task Force as a Subcommittee through NABIMY-32-15. See
26 Exhibit C.

27 B. The Naabik'iyáti' Committee subsequently approved NABIMY-42-17 that amended
28 NABIMY-32-15 to provide for six members (two members from each state of
29 Arizona, New Mexico and Utah). See Exhibit B.

1 C. The Naabik'iyáti' State Task Force Subcommittee is charged with conducting regular
2 interaction with Navajo Nation lobbyists, state legislatures, officials, employees and
3 other agencies to advance the position and priorities of the Navajo Nation within the
4 states of Arizona, New Mexico and Utah. *See Exhibit C.*

5 D. The Speaker of the Navajo Nation Council appoints the following Delegates to serve
6 as members on the Naabik'iyáti' State Task Force. *See Exhibit C.*

8 **SECTION THREE. APPOINTMENT**

9 A. The Speaker of the 25th Navajo Nation Council hereby appoints the following
10 Delegates to the Naabik'iyáti' State Task Force Subcommittee:

- 11 1. Hon. Carl R. Slater from Arizona;
- 12 2. Hon. Shawna A. Claw from Arizona;
- 13 3. Hon. Seth A. Damon from New Mexico;
- 14 4. Hon. Nathan Notah from New Mexico;
- 15 5. Hon. Herman M. Daniels, Jr. from Utah; and
- 16 6. Hon. Curtis Yanito from Utah.
