23	B. The Resources and Development Committee shall review and make recommendations to	
24	the Budget and Finance Committee concerning the budget in accordance with the annual	
25	budget instructions. 12 N.N.C. § 840 (A).

27	SECTION TWO. FINDINGS	
28	A. Oversight Committee recommendations shall not exceed the base planning amounts. 12	
29	N.N.C. §840(A). The base planning amounts were established by the Budget and	
30	Finance Committee through Resolution No. BFJY-15-23.	

B. The Resources and Development Committee held budget meetings and heard reports from Program staff and the Office of Management and Budget regarding the proposed FY2024 Budget for the Division of Natural Resources. 12 N.N.C. §840(A).

- C. The Resources and Development Committee reviewed and considered the proposed FY2024 Budget for the Division of Natural Resources, as compared to the base planning amounts, Resolution No. BFJY-15-23, and as recommended by the Office of Management and Budget.

- A. The Resources and Development Committee hereby approves the FY2024 Budget for the Division of Natural Resources, as detailed in the "Fund Type Budget Summary" attached hereto as **Exhibit A**.
- B. The Resources and Development Committee hereby approves certain revisions to the Branch Chiefs' proposed FY2024 Budget amount for the Division of Natural Resources, as shown in Columns D and E in the "General Fund Comparative Summary" attached hereto as Exhibit B.

C. The Resources and Development Committee recommends the changes to the General Fund Budget described in Exhibit C.

- D. The Resources and Development Committee recommends certain Conditions of Appropriation and Legislative Concerns, as listed in Exhibit D.
- E. The Resources and Development Committee recommends that certain Unmet Needs for the Division of Natural Resources be included in the FY2024 Comprehensive Budget, as explained in Exhibit E.
- F. The Resources and Development Committee recommends that the Budget and Finance Committee approve the Division of Natural Resources FY2024 Budget and all

Committee recommendations as set forth in Exhibits A-E. G. The Resources and Development Committee hereby authorizes the Chairwoman and the Vice-Chairman to negotiate with the Budget and Finance Committee on these recommendations. SECTION FOUR.
