**AN ACTION**

**RELATING TO THE RESOURCES AND DEVELOPMENT COMMITTEE;  
APPROVING AND RECOMMENDING TO THE BUDGET AND FINANCE  
COMMITTEE THE FISCAL YEAR 2024 BUDGET FOR THE DIVISION OF  
TRANSPORTATION AND RELATED MATTERS, TO BE INCLUDED  
IN THE NAVAJO NATION’S FY2024 COMPREHENSIVE BUDGET**

BE IT ENACTED:

**SECTION ONE. AUTHORITY**

- A. The Resources and Development Committee is a standing committee of the Navajo Nation Council with oversight authority over the Navajo Nation Division of Transportation. 2 N.N.C. §500(A); 2 N.N.C. §501(C)(1).
- B. The Resources and Development Committee shall review and make recommendations to the Budget and Finance Committee concerning the budget in accordance with the annual budget instructions. 12 N.N.C. § 840 (A).

**SECTION TWO. FINDINGS**

- A. Oversight Committee recommendations shall not exceed the base planning amounts. 12 N.N.C. §840(A).
- B. The Resources and Development Committee held budget meetings and heard reports

1 from Program staff and the Office of Management and Budget regarding the proposed  
2 FY2024 Budget for the Division of Transportation. 12 N.N.C. §840(A).

- 3 C. The Resources and Development Committee finds that approval of the proposed FY2024  
4 Budget for the Division of Transportation and inclusion of such Budget in the Navajo  
5 Nation's FY2024 Comprehensive Budget is in the best interest of the Navajo Nation.

7 **SECTION THREE. APPROVING AND RECOMMENDING TO THE BUDGET AND**  
8 **FINANCE COMMITTEE THE FISCAL YEAR 2024 BUDGET FOR THE DIVISION**  
9 **OF TRANSPORTATION AND RELATED MATTERS**

10 A. The Resources and Development Committee hereby approves the FY2024 Budget for  
11 the Division of Transportation, as detailed in the "Fund Type Budget Summary" attached  
12 hereto as **Exhibit A**.

13 B. The Resources and Development Committee hereby approves certain revisions, if any,  
14 to the Branch Chiefs' proposed FY2024 Budget amount for the Division of  
15 Transportation, as shown in Columns D and E in the "General Fund Comparative  
16 Summary" attached hereto as **Exhibit B**.

17 C. The Resources and Development Committee recommends the changes, if any, to the  
18 General Fund Budget described in **Exhibit C**.

19 D. The Resources and Development Committee recommends certain Conditions of  
20 Appropriation and Legislative Concerns, if any, as listed in **Exhibit D**.

21 E. The Resources and Development Committee recommends that certain Unmet Needs, if  
22 any, for the Division of Transportation be included in the FY2024 Comprehensive  
23 Budget, as explained in **Exhibit E**.

24 F. The Resources and Development Committee recommends that the Budget and Finance  
25 Committee approve the Division of Transportation FY2024 Budget and all Committee  
26 recommendations as set forth in **Exhibits A-E**.

27 G. The Resources and Development Committee hereby authorizes the Chairwoman and the  
28 Vice-Chairman to negotiate with the Budget and Finance Committee on these  
29 recommendations.
