
**PURPOSE:** This resolution, if approved, will enact a Plan of Operation for the Office of the Speaker.

15 SECTION ONE. AUTHORITY

16 A. The Naabik'iyati Committee is a standing committee of the Navajo Nation Council that  
17 serves as the oversight committee for the Office of Legislative Services and other offices,  
18 programs, commissions, boards or task forces under the Legislative Branch of the Navajo  
19 Nation. 2 N.N.C. § 701 (A) (5).

20  
21 SECTION TWO. FINDINGS

- 22 A. The Office of the Speaker of the Navajo Nation Council (Office of the Speaker) is  
23 established under the Legislative Branch in 2 N.N.C. § 281 (A). The Speaker of the  
24 Navajo Nation Council is authorized by law to direct and supervise the personnel and  
25 programs under the Legislative Branch. 2 N.N.C. § 285 (B) (2).
- 26 B. The purpose of this legislation is to approve a Plan of Operation for the Office of the  
27 Speaker attached as **Exhibit A**.
- 28 C. Pursuant to the Plan of Operation for the Office of the Speaker attached as **Exhibit A**,  
29 the Office of the Speaker purposes are:

- 1        1. Provide support and assistance to the Speaker of the Navajo Nation Council in
- 2            carrying out the Speaker's duties.
- 3        2. Ensure the efficient administration and support of daily business and activities of the
- 4            Navajo Nation Council and its Standing Committees.
- 5        3. Ensure the efficient operation of the programs under the Legislative Branch.
